## Aperol Contest for Coachella Tickets – US Official Rules

### **Aperol Sweepstakes for Coachella Tickets**

#### **Official Rules**

- **NO PURCHASE OR PAYMENT IS NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES. A PURCHASE OR PAYMENT OF ANY KIND DOES NOT INCREASE YOUR CHANCES OF WINNING.**
- **VOID WHERE PROHIBITED BY LAW.**
- **ALL DISPUTES WILL BE RESOLVED SOLELY BY BINDING ARBITRATION AND ENTRANTS WAIVE THE ABILITY TO BRING CLAIMS IN A CLASS ACTION FORMAT.**
- **THIS SWEEPSTAKES IS IN NO WAY SPONSORED, ENDORSED, ADMINISTERED BY, OR ASSOCIATED WITH X (TWITTER), PINTEREST, META (FACEBOOK), OR INSTAGRAM.**

BY ENTERING (OR OTHERWISE PARTICIPATING IN) THE SWEEPSTAKES, ENTRANTS AGREE TO THESE OFFICIAL RULES, WHICH ARE A BINDING CONTRACT, SO READ THEM CAREFULLY BEFORE ENTERING. WITHOUT LIMITATION, THIS CONTRACT INCLUDES INDEMNITIES TO THE SWEEPSTAKES PARTIES FROM YOU AND A LIMITATION OF YOUR RIGHTS AND REMEDIES.

1. **ELIGIBILITY:** The Aperol Sweepstakes for Coachella Tickets (“Sweepstakes”) is open only to individuals who are legal residents and physically located in one (1) of the fifty (50) United States or the District of Columbia, and who are at least twenty-one (21) years of age or older as of time/date of entry. Employees, officers and directors of Campari America, LLC (“Sponsor”), Berlin Cameron, M Booth, TPN, SWELL, Small Agency, Wunderman Thompson, MindShare, Soho Experiential, AEG, Goldenvoice, LLC, AEG Presents LLC, Anschutz Entertainment Group Inc., CVM&AF, LLC, Empire Polo Club, Inc. Empire Polo Club, Inc., Empire II, LLC, HCL Slauson Overhill LLC, Madison Polo, LLC, Empire 50 North, LLC, 50 Horses, LLC, Empire Hjorth LLC, EPC Landscaping, LLC, and each of their respective parents, affiliates, subsidiaries, officers, directors, representatives, shareholders, members, agents, employees, subcontractors, Realtime Media LLC (“Administrator”) and their respective parent companies, affiliates, subsidiaries, advertising, sweepstakes, contest, fulfillment and marketing agencies (collectively, the “Sweepstakes Parties”), suppliers, distributors, wholesalers, or retailers of alcohol-beverage products, their immediate family members and those living in the same household as such individuals (whether legally related or not) are not eligible to participate in the Sweepstakes or win a prize. For purposes of this Sweepstakes, immediate family members are defined as spouse, partner, parents, legal guardians, in-laws, grandparents, siblings, children and grandchildren, and those living in the same household shall mean

people who share the same residence at least three (3) months a year, whether legally related or not. By participating, you agree to these Official Rules and to the decisions of the Sponsor and Administrator, which are final and binding in all respects. Void where prohibited by law, rule or regulation. By participating in the Sweepstakes, each entrant unconditionally accepts and agrees to comply with and abide by these "Official Rules" and the decisions of Sponsor, including the interpretation of these Official Rules and its exercise of discretion, which will be final and binding in all respects.

2. **TIMING:** The Sweepstakes begins on or about 12:00:00 p.m. (noon) Eastern Time ("ET") on January 22, 2024, and all entries must be received by the Sponsor on or before 11:59:59 p.m. ET on March 15, 2024 (the "Sweepstakes Period"). The designated computer clock of the Administrator is the official time-keeping device in the Sweepstakes.
3. **HOW TO ENTER:** There are three (3) methods of completing an online registration form for a total of one (1) entry and one (1) method for obtaining additional entries via Sweepstakes share, as described below:

**Complete Online Entry Form (see limit below):**

- a) **On Sweepstakes Microsite:** During the Sweepstakes Period, visit <https://coachellacontest.aperol.com/us/> and follow the links and instructions to complete and submit an official entry form including your full name, valid email address date of birth, and any other related entry information, to be eligible for entry. Once you have done so, you will receive one (1) entry into the Sweepstakes, subject to the limit below.
- b) **Via Meta (Facebook) Advertising Invitation:** During the Sweepstakes Period, if you are eligible and are invited via an advertisement by Sponsor to enter the Sweepstakes via a registration form on Meta (Facebook), follow the call to action by clicking on the ad, clicking next, allowing the form to auto-populate with your information, clicking next, optionally checking a box to opt in for marketing, then seeing the confirmation of your entry. Once you have done so, you will receive one (1) entry into the Sweepstakes, subject to the limit below.
- c) **Via Instagram Advertising Invitation:** During the Sweepstakes Period, if you are eligible and are invited via an advertisement by Sponsor to enter the Sweepstakes via a registration form on Instagram, follow the call to action by clicking on the ad, clicking next, allowing the form to auto-populate with your information, clicking next, optionally checking a box to opt in for marketing, then seeing the confirmation of your entry. Once you have done so, you will receive one (1) entry into the Sweepstakes, subject to the limit below.

**If You Entered Via the Sweepstakes Microsite - Sweepstakes Share Method of Obtaining Additional Entries:** After entering via the Sweepstakes Microsite, you may obtain additional Sweepstakes entries by using the share functionality provided to post a prepopulated message promoting the Sweepstakes on your X (Twitter) or Pinterest Account to invite a friend (who also must be eligible per Section 1, above) to enter the Sweepstakes. For each share message sent using the share functionality provided by Sponsor where the individual who receives the message enters the Sweepstakes using the link provided, you will receive one (1) additional entry into the Sweepstakes, up to a maximum of ten (10) additional entries (up to five (5) each via X (Twitter) and via Pinterest share). Do not invite anyone under the age of 21 and/or anyone not eligible for this Sweepstakes.

Limit of one (1) entry per person for completing an online entry form during the Sweepstakes Period (regardless of method or combination of methods of entry) (and up to ten (10) additional entries, as described above). Subsequent attempts made by the same individual to submit more than the stated number of entries by using multiple or false contact information, accounts, or otherwise may result in the entrant being disqualified. Entries generated by a script, computer program, macro, programmed, robotic or other automated means are void and may be disqualified. Entries that are in excess of the stated limits, incomplete, illegible, corrupted, damaged, destroyed, forged, false, lost, late or misdirected, deceptive or otherwise not in compliance with the Official Rules may be disqualified from the Sweepstakes at Sponsor's sole and absolute discretion. Entries submitted by entrants who do not meet the eligibility requirements (including all requirements with respect to age and residence) are void. In the event of a dispute over the identity of an online entrant, entry will be deemed submitted by the registered account holder of the email address associated with the entry, provided that person is eligible. The potential winner may be required to show proof of being a registered account holder. Registered account holder is defined as the person assigned to an email address by an Internet access provider, online service provider, or other organization responsible for assigning email addresses. In the event that a dispute regarding the identity of the individual who actually submitted an entry cannot be resolved to Sponsor's satisfaction, the affected entry will be deemed ineligible. Those who do not follow all of the instructions, provide the required information in their entry form, or abide by these Official Rules or other instructions of Sponsor may be disqualified.

4. **SWEEPSTAKES DRAWING:** There will be one (1) winner selected in this Sweepstakes during the entire Sweepstakes Period, via a random drawing on or about March 18, 2024, from all eligible entries received in accordance with these Official Rules. The Sponsor and Administrator will have complete discretion over interpretation of the Official Rules, of administration of the Sweepstakes, and of selection of the potential winner. Decisions of the Sponsor and Administrator as to the selection of the potential winner will be final and binding.
5. **ODDS:** Odds of winning the Sweepstakes prize will depend on the total number of eligible entries received during the Sweepstakes Period.
6. **WINNER NOTIFICATION/PRIZE CLAIMING:** The potential winner will be notified using the email address provided during entry in a commercially reasonable time after the drawing. The Sweepstakes Parties are not responsible for false, incorrect, changed, incomplete, or illegible contact information. Notification is deemed to have occurred immediately upon sending of an email. As part of the winner notification process, the potential winner will be required to complete and submit a declaration of eligibility / release of liability / prize acceptance agreement (collectively, the "Declaration") within three (3) days as a condition of receiving the prize. If the potential winner fails or refuses to sign and return the Declaration within the required time or if the Declaration is returned as rejected, faulty, unclaimed, or returned as undeliverable to potential winner, potential prize winner will be disqualified, and an alternate may be selected, up to three (3) alternates, if time permits, after which the prize will remain un-awarded. P.O. Boxes are not permitted. The Sweepstakes Parties are not responsible for electronic communications that are undeliverable as a result of any form of active or passive filtering of any kind, or insufficient space in entrant's email or other account to receive messages.

If the potential winner cannot be contacted within a reasonable time period, if potential winner is ineligible, if any notification is returned undeliverable, or if the potential winner otherwise fails to fully comply with these Official Rules, he/she will forfeit that prize and an alternate potential winner may be selected from among all remaining eligible entries, up to three (3) alternates, if time permits, after which the prize will remain un-awarded.

Potential winner will be confirmed as the "Winner" only after verification of eligibility by Sponsor. No more than the stated prize will be awarded. If, for any reason, more bona fide winners come forward seeking to claim prizes in excess of the prize set forth in these Official Rules, the winner of the advertised prize available may be selected in a random drawing from among all persons making purportedly valid claims for such prize. Inclusion in such drawing shall be each entrant's sole and exclusive remedy under such circumstances. The Sweepstakes Parties are not responsible for and shall not be liable for late, lost, damaged, intercepted, misdirected, or unsuccessful efforts to notify the potential winner.

**7. PRIZE/PRIZE RESTRICTIONS:** One (1) Grand Prize ("Grand Prize" or "Trip Prize"), will be awarded in this Sweepstakes.

**One (1) Grand Prize:** One (1) Trip Prize consisting of: round trip ground transportation between the winner's home and the departing airport; three (3) round trip economy/coach airline tickets for the winner and two (2) guests (must be 21+) via a Sponsor-selected air carrier(s) from a major commercial airport selected by Sponsor in its sole and absolute discretion; a four (4)-night hotel stay (Sponsor's choice of one (1) or two (2) standard rooms, 4/18/24 – 4/22/24) in a city near the event; three (3) VIP tickets to the Coachella Valley Music & Arts Festival 2024 for the second weekend (scheduled for April 19 – 21, 2024) (the "Festival"); round trip ground transportation between airport and hotel at Festival destination; three (3) shuttle passes that may be used for ground transportation between hotel and Festival; \$450 in gift cards for winner that may be used for spending money; and a gift in the room for winner only, all details determined by Sponsor in its sole discretion. Winner will also receive a check for \$5,000 that may be used toward taxes.

Total Approximate Retail Value ("ARV") of this Grand Prize is: \$21,007. The actual retail value of Trip Prize may vary depending on point of departure, travel dates and fare/rate fluctuations. If the actual value of the prize is less than the stated ARV, the difference will not be awarded. All travel arrangements must be made through the Sponsor or Sponsor's designee. Certain restrictions may apply. The winner of the Trip Prize must travel as and when designated by Sponsor (and surrounding the Festival dates) or the Trip Prize may be forfeited, and an alternate, randomly-selected winner will be chosen, if time permits.

**The total ARV of the prizes in this Sweepstakes is \$21,007.**

Winner and guests must travel together and on the same itinerary. Winner and guests must provide proper documentation (including government-issued picture identification) and must possess all required travel documents, including visas and valid passports, if and as applicable. All aspects of the travel portions of the Trip Prize must be conducted on the dates as determined by Sponsor in its sole and absolute discretion and surrounding the Festival dates. The dates of departure and return are subject to change at the Sponsor's sole and absolute discretion. Airline tickets are non-refundable/non-transferable and are not valid

for upgrades and/or frequent flyer miles. Travel must be booked at least two (2) weeks prior to travel and all travel must be completed on the dates surrounding the Festival or prize will be forfeited. All airline tickets are subject to flight variation, work stoppages, and schedule or route changes. Sponsor reserves the right to structure travel route and select hotels in its sole and absolute discretion. Trip Prize winner will not receive cash or any other form of compensation if actual travel costs are less than the estimate made in these Official Rules. The round-trip air transportation element for the Trip Prize begins and ends at the point of departure. The Trip Prize is subject to seat and hotel availability, as well as Sponsor's terms and conditions generally applicable thereto. If, in the judgment of Sponsor, air travel is not required due to winner's proximity to Trip Prize location, ground transportation will be substituted for roundtrip air travel at Sponsor's sole and absolute discretion. The difference in value will not be awarded to the Trip Prize winner.

Sponsor shall not be responsible for any cancellations, delays, diversions or substitution or any act or omissions whatsoever by the air carriers, hotels, venue operators, transportation companies, prize providers or any other persons providing any Trip Prize-related services or accommodations. The Sponsor is not liable for any missed prize events, opportunities, or expenses incurred as a consequence of flight cancellation/delay or ground transportation delay. No refund or compensation will be made in the event of the cancellation or delay of any transportation or other prize element except at the sole and absolute discretion of Sponsor. Additional prize award details and travel information to be provided to the Trip Prize winner at the time of Trip Prize notification. Trip Prize winner and guests are responsible for obtaining travel insurance (and all other forms of insurance) at their option and hereby acknowledge that Sponsor has not and will not obtain or provide travel insurance or any other form of insurance. Winner may be required to provide a credit card at the time of hotel check-in. Guests must be at least 21 years of age as of the date of booking travel. Guests must execute liability/publicity releases prior to issuance of travel documents. Once a guest is selected, he/she may not be substituted, except in Sponsor's sole and absolute discretion. Travel is subject to the terms and conditions set forth in this Sweepstakes, and those set forth by Sponsor's transportation carrier(s) of choice. Lost, stolen or damaged airline tickets, travel vouchers or certificates will not be replaced or exchanged. All expenses not specifically mentioned herein, are not included as part of any Trip Prize package, and are solely the Trip Prize winner's responsibility, including, but not limited to: hotel taxes, additional ground transportation at the Trip Prize winner's destination, travel insurance, room service, bag check fees, parking fees, laundry service, food, alcoholic beverages, merchandise, souvenirs, telephone calls, tips, gratuities, and service charges. Transportation carrier and hotel regulations and conditions apply. Travel and lodging are subject to availability, and any changes made to either of these will be at the expense of the Trip Prize winner.

If, for whatever reason, the event associated with the prize is cancelled after the prize is awarded, Sponsor's liability for the prize is limited only to the non-event portions of the prize. No compensation will be paid in lieu of the cancelled event. The tickets to the event are subject in all respect to the terms and conditions set forth on the tickets and any requirements of the facility hosting the event. Seat locations (if applicable) will be determined by the Sponsor in its sole discretion. Winner is strictly prohibited from selling, auctioning, trading or otherwise transferring the tickets unless Sponsor consents in writing. In the event winner (and/or his or her guest(s)) engage in behavior that (as determined by Sponsor or any prize provider in its or their sole and absolute discretion) is obnoxious, inappropriate, or threatening, illegal or that is intended to annoy, abuse, threaten, or harass any other person, Sponsor reserves the right to terminate the applicable experience early. Decisions regarding the conduct of the winner and guests in all aspects of their participation in the prize event/activity will be in the sole discretion of Sponsor, and any of Sponsor's representatives and final and binding in all respects. Winner and/or guest(s) may be removed or disqualified from participating in any aspect of the prize for any reason at any time, including, without limitation, creating an unauthorized disturbance, interruption or unnecessarily rough physical contact, creating the potential for injury or property damages, or for any unhealthy, unsafe, unlawful, or inappropriate act. If winner or any

guest, in the opinion of Sponsor or any of Sponsor's representatives, is considered a physical or mental threat to the well-being of any other individual, he/she may be removed from any premises relating to the prize and winner consents to such removal.

**FOR CONCERTS AND OTHER TICKETED EVENTS:** Any other expenses or items not specifically listed, including but not limited to, transportation, accommodations, meals, parking and souvenirs, are the responsibility of winner and/or winner's guests. All guests must be twenty-one (21) years or older. If the ticketed event or any portion thereof is postponed, rained out, canceled, or for other reasons beyond Sponsor's and Festival organizers' control does not occur, the Sponsor and Festival organizers will not be responsible for replacing the ticketed portion of prize. Tickets are subject to certain terms and conditions specified thereon, and seat locations (if any) are as solely determined by Sponsor and Festival organizers. Lost or stolen tickets or passes will not be replaced. The Sponsor and Festival organizers shall not be responsible for any cancellations, delays, diversions or substitution or any act or omissions whatsoever by the venue operator, prize provider or any other persons providing any prize-related services. If travel delays, cancellations or difficulty prevent arrival in time for the event, the Sponsor and Festival organizers (or other Released Parties) are not responsible for awarding any compensation in lieu thereof. Tickets must be redeemed as stated in the prize notification or otherwise stated in the Official Rules. Winner agrees to accept all space availability requirements established by the venue. Winner and guests must comply with all applicable laws, and any rules and regulations established by the venue. Sponsor, Festival organizers, and the applicable venue representatives reserve the right to remove or to deny entry to winner (and guests) who engage in a non-sportsmanlike or disruptive manner, or with intent to annoy, abuse, threaten or harass any other person at the event or in any other objectionable behavior. Winner agrees that acceptance of the prize is done so entirely upon their own initiative, risk, and responsibility.

**FOR PRIZE-RELATED EVENTS: COVID-19 Release and Waiver:** Winner understands and agrees that attending an event, in connection with the prize, will be dangerous due to the Coronavirus (COVID-19) epidemic/pandemic and assumes any and all risks of illness, injury or loss due to such attendance. Winner acknowledges that, notwithstanding the safety precautions taken by the venue, and other providers of services related to the prize, it is possible that he/she may still contract Coronavirus (COVID-19). Additionally, winner understands and agrees that, in response to economic and/or social conditions engendered by the Coronavirus (COVID-19), Sponsor or Festival organizers may be compelled to modify, postpone or cancel the event. In all cases, winner releases and agrees to hold harmless Sponsor, Festival organizers (as well as the other Released Parties) from any and all liability in conjunction therewith and, in no event, shall Sponsor, Festival organizer (as well as the other Released Parties), have any liability in excess of the above-indicated ARV of the prize. The prize winner and guests must conduct themselves at all times in a socially responsible, respectful and appropriate manner including following all private guidance from venue operator and other prize suppliers as well as governmental mandates intended and designed to prevent contracting and/or spreading COVID-19/Coronavirus; which may include but are not limited to maintaining social distancing, mask-wearing, testing and may also include quarantine (if mandated).

Prize is non-transferable, with no cash redemptions, equivalents, or substitutions except at Sponsor's sole and absolute discretion. All prize details not specified in these Official Rules will be determined in Sponsor's sole and absolute discretion. Prize details and availability are subject to change and prize provider's rules and restrictions, and in the event that Sponsor is unable to provide winner with the prize, the Sponsor may elect to provide winner with the approximate value of such item in cash or award an alternate prize of comparable or greater value. Prize is awarded "AS IS" and without warranty of any kind, express or implied

(including, without limitation, any implied warranty of merchantability or fitness for a particular purpose). Winner will be solely responsible for all federal, state and/or local taxes, and for any other fees or costs associated with the prize received, regardless of whether they, in whole or in part, are used. The ARV of the prize is based on available information provided to Sponsor and the value of the prize awarded will be reported for tax purposes as required by law. The winner will be required to provide Sponsor with a valid social security number before the prize will be awarded, for tax reporting purposes. An IRS Form 1099 will be issued in the name of winner, for the actual value of the prize received. Any unclaimed prize will be forfeited. Prize, if legitimately claimed, will be awarded. The Sweepstakes Parties are not responsible for and will not replace any lost, mutilated or stolen prize or any prize that is undeliverable or does not reach the winner because of an incorrect or changed address. If winner does not accept or use the entire prize, the unaccepted or unused part of the prize will be forfeited, and the Sweepstakes Parties will have no further obligation with respect to that prize or portion of the prize. No more than the stated prize will be awarded. The Sweepstakes Parties are not responsible for and winner will not receive the difference, if any, between the actual value of the prize at the time of award and the stated ARV in these Official Rules or in any Sweepstakes-related correspondence or material. Winner will be contacted regarding prize fulfillment within three (3) to five (5) days after winner is confirmed after the end of the Sweepstakes.

8. **GENERAL:** Subject to applicable law, winner hereby expressly grants to the Sweepstakes Parties and their respective successors, assigns, sublicensees and designees, the irrevocable right to use and publish his/her name, image, photo, voice, likeness and/or place of residence ("winner's Likeness") for all purposes, including, without limitation, advertising, marketing, promotional and publicity purposes in connection with this Sweepstakes ("Advertising"), in any and all media now or hereafter devised, worldwide, in perpetuity, without any form of notice, permission or any amount or kind of compensation, except for the awarding of the prize to the winner. All copyright, trademark, or other intellectual property rights in such Advertising shall be owned by Sponsor and/or its licensors, and each winning participant hereby disclaims and waives any claim of right to such Advertising. Such Advertising shall be solely under the control of Sponsor and/or its licensors, and winner hereby waives any claim of control over the Advertising content as well as any possible claims of misuse of such winner's Likeness under contract, tort or any other theory of law. The Sweepstakes Parties do not assume any responsibility for any disruption in the Sweepstakes Parties, including, but not limited to, the failure or interruption of any social media platform or any internet service provider. In the event there is a discrepancy or inconsistency between disclosures and other statements contained in any Sweepstakes materials and the terms and conditions of these Official Rules, these Official Rules shall prevail, govern, and control. All decisions as to these Official Rules and interpretations thereof are exclusively within the sole discretion of the Sweepstakes Parties and may be changed from time to time without notice. In the event Sponsor is prevented from continuing with the Sweepstakes by any event beyond its control, including, but not limited to, fire, flood, epidemic, pandemic, earthquake, explosion, labor dispute or strike, act of God or public enemy, communications or equipment failure, utility or service interruptions, riot or civil disturbance, terrorist threat or activity, war (declared or undeclared), interference with the Sweepstakes by any party, or any federal, state, or local government law, order, or regulation, order of any court or jurisdiction, or other cause not reasonably within Sponsor's control (each, a "Force Majeure" event or occurrence), Sponsor shall have the right to modify, suspend or terminate the Sweepstakes or prize. Sponsor additionally reserves the right, in its sole and absolute discretion: (a) to modify, suspend or terminate the

Sweepstakes should causes beyond Sponsor's control corrupt or interfere with the administration, integrity, operation, security or proper play of the Sweepstakes; or (b) to disqualify any entrant found to be, or suspected of: (i) tampering with the entry process or the operation of the Sweepstakes; (ii) acting in violation of these Official Rules; or (iii) acting in an un-sportsmanlike manner.

9. **CONDUCT:** The Sweepstakes Parties are not responsible for the actions of entrants in connection with the Sweepstakes, including entrants' attempts to circumvent the Official Rules or otherwise interfere with the administration, security, fairness, integrity or proper conduct of the Sweepstakes. The Sweepstakes Parties reserve the right, at their sole discretion, to disqualify any individual found to be tampering with the participation process or the operation of the Sweepstakes, or to be acting in any manner deemed by the Sweepstakes Parties to be in violation of the Official Rules, or to be acting in any manner deemed by the Sweepstakes Parties to be unsportsmanlike or disruptive, or with intent to annoy, abuse, threaten or harass any other person and void all associated Entries and/or registrations. CAUTION: ANY ATTEMPT BY A USER, YOU, OR ANY OTHER INDIVIDUAL TO DAMAGE OR UNDERMINE THE LEGITIMATE OPERATION OF THE SWEEPSTAKES IS A VIOLATION OF CRIMINAL AND CIVIL LAWS, AND SHOULD SUCH AN ATTEMPT BE MADE, THE SWEEPSTAKES PARTIES RESERVE THE RIGHT TO SEEK DAMAGES AND OTHER REMEDIES (INCLUDING ATTORNEYS' FEES) FROM ANY SUCH PERSON TO THE FULLEST EXTENT PERMITTED BY LAW. Sponsor reserves the right, in its sole and absolute discretion, to disqualify (or terminate the prize of) any individual who is found to be, or suspected of, acting in violation of these Official Rules, or to be acting in an unsportsmanlike, obscene, immoral or disruptive manner, or with the intent to annoy, abuse, threaten, or harass any other person.
